# recordings

No Brother I have ever met has more of the old Phi Alpha spirit than John Henry (Wimpy) Stone, '57, West Virginia Alpha (Marshall). A long-time member of the Leadership School faculty, Brother Stone is on the Dean's staff at Westminster College, New Wilmington, Pennsylvania. He is a former Chapter Consultant.

John Henry's talents are many, but none predominate as much as his means of communicating through the medium of singing—and in particular, his style of leading a group of Brothers in song to arouse their interest and set the tone of the entire meeting.

This was never more in evidence than in San Francisco, where John teamed up with Brothers Carl Kimball at the piano and Fred Phelps at the organ to begin each session of the 113th Anniversary Convention with rousing choruses of "Come Sing To," "Hail to the Purple," "Dear SAE," and many of the other favorites.

John would stand on a chair (he's rather small in stature), a straw, cowboy-like hat perched on his head and a microphone in his hand, and go to work doing what he likes best to do.

"Phi Alpha," he would say into the microphone.

"Phi Alpha," the Brothers on the convention floor would answer back.

"I can't hear you," John would lament. "Phi Alpha!"

The return cry of Phi Alpha was louder.

"Phi Alpha," John shouted again with vigor.

The reply back was deafening. John had accomplished his mission.

To give you some idea of John's devotion to Minerva, he and his wife and young daughter trekked across the country in a camper to get to the Convention. And the trip took two weeks—vacation time, at that—to complete.

In March, John, along with Fred Phelps, was asked by the Brothers of New York Epsilon at Rensselaer Polytechnic Institute to attend a Chapter Retreat. This is the letter the Brothers wrote describing the event:

"With Fred playing the piano and John Henry as song leader, they started the Retreat in good fashion on Saturday morning to get ready for the more serious aspects and purposes of the rest of the day . . . John Henry and Fred both sat in on discussions, adding a very helpful 'outside the House' view to the problems at hand."

John Henry Stone is that type of Brother. He brings out the best in everyone he meets, and in the age of the generation gap, he is able to communicate with young and old alike.

Sigma Alpha Epsilon is fortunate and proud to have John Henry Stone a Brother in the Bonds.

A man who deserves a great deal of credit for the success of the 113th Anniversary National Convention is Brother Edwin M. Wilson, '47, North Carolina Nu (Duke), Archon of Province Kappa and Convention Chairman.

Hosting a National Convention is no easy task, as Brother Wilson will readily admit. There are innumerable tasks to be performed, funds to be secured for incidentals and last minute details to be worked out with oh so many people.

Brother Wilson's first order of business was to organize the "113 Club," a club composed of Brothers living in the San Francisco area who were asked to pay \$13.00 to help defray costs in hosting the Convention.

"We had a tremendous turnout," said Ed. "We had originally hoped for 113 Brothers to respond to our request. We wound up with 226 members who contributed nearly \$3,500."

The Sheraton Palace Hotel provided excellent accommodations, and despite an afternoon fog, a three-hour bus tour of San Francisco's many points of interest was applauded by the delegates.

Clark University in Worcester, Mass., dedicated its new \$5.4 million Goddard Library May 19. The building is named in honor of the late Dr. Robert H. Goddard, '08, Mass. Delta (Worcester Polytechnic Institute), famed rocket pioneer and a long-time member of the Clark faculty. U. S. Senator Edward M. Kennedy was the principal speaker.

# SUCCESS IN SAN FRANCISCO



*WELCOME—Rear Adm. Leo J. McCuddin, '39, Nevada Alpha (Nevada), Commandant of the 12th Naval District and Honorary Archon of Province Kappa, welcomed the Brothers to San Francisco. "One hundred and thirteen years is a long time for San Francisco to wait for an  $\Sigma$ AE Convention," the World War II and Korean War fighter pilot veteran said. "I hope the next time won't be so long."*

San Francisco Mayor Joseph L. Alioto, in proclaiming June 15-21, 1969, SIGMA ALPHA EPSILON WEEK, wrote, "Sigma Alpha Epsilon is founded upon the philosophy that men in college living together can learn much from each other and can give mutual aid and assistance in the development of their character and personalities."

Never was the Fraternity's philosophy more in evidence than at the 113th Anniversary Convention, where more than 275 undergraduate delegates and alternates joined with nearly 70 alumni delegates in electing a new Supreme Council and approving legislation that will govern the fraternity the next two years.

"There's nothing like a National Convention to get the Phi Alpha juice stirring," one delegate remarked laughingly in the elevator. He just may have been only half kidding, for there was a great sigh when ESA Roy L. Miller finally gaveled the Convention to a close nearly two hours past the normal closing Wednesday.

The three days of meetings in the great hall of the Sheraton-Palace Hotel produced results that will be felt throughout the Greek world. This was a working Convention in the nation's number one Convention city. It was a Convention marked with discussion on the

floor and long bull sessions in rooms lasting well into the morning. Tempers flared on occasion, but in the end there was harmony.

The man elected Eminent Supreme Archon for the next two years, Paul B. Jacob, Jr., '44, Mississippi Theta (Mississippi State), has devoted much of his adult life to Sigma Alpha Epsilon. Former Archon of Province Theta, he was first elected to the Supreme Council at the 1961 Convention in Yellowstone Park, Wyoming. He presently holds the position of Professor of Electrical Engineering at Mississippi State University.

ESA Jacob was nominated for the highest office in the Fraternity by his son, William, '71, Miss. Theta.

Re-elected to the Council were: Robert P. van Blaricom, '33, Ohio Theta (Ohio State), Eminent Supreme Deputy Archon; Joseph A. Mancini, '35, Ohio Epsilon (Cincinnati), Eminent Supreme Warden; and Russell P. Heuer, '55, Pennsylvania Theta (Pennsylvania), Eminent Supreme Herald.

The newest member of the Council is Brother Neal R. Berte, '62, Ohio Epsilon (Cincinnati), who will serve as Eminent Supreme Chronicler. Dr. Berte, a nationally known lecturer on higher education, is Executive Assistant for the President of Ottawa University, Ottawa, Kan. He has served as

Brother Beck, ESA from 1961 to 1963, was later awarded the Distinguished Service Award, the fraternity's highest single honor. It will be bestowed upon him at a later date at a celebration in Pittsburgh, Pa.

Accepting on behalf of the Fraternity was Honorary Eminent Supreme Archon Robert L. Cousins, '23, Georgia Psi (Mercer).

Surprisingly enough, June 15, the opening day of the Convention, was also the birthday of ESA Roy L. Miller.

Despite the high number of undergraduate delegates in attendance, two Chapters failed to attend and some 10 others were not seated by the credentials committee for failure to adhere to pre-Convention procedures.

The highlight of the Convention came during the Tuesday sessions when 11 petitioning locals were granted charters following long deliberation by the extension committee and debate on the convention floor. The committee was co-chaired by Brothers Louis Smith, Archon of Province Tau, and Richard G. Evans of Illinois Psi-Omega (Northwestern). To them and the entire committee goes a vote of thanks for a job well done.

Stern faces, then smiles, then shouts of joy from our new Brothers were heard as ESA Miller said, "It is my pleasure and privilege on behalf of the 113th Anniversary Convention to inform you that by action of this Convention you have

been granted a charter in Sigma Alpha Epsilon."

Post College, Greenvale, Long Island, N.Y.; Phi Alpha, Colorado State College, Greeley, Colo.; Lambda Psi, Middle Tennessee State University, Murfreesboro, Tenn.; Phi Alpha, Indiana State University, Terre Haute, Ind.; Sigma Phi Delta, Tennessee Technological University, Cookeville, Tenn.; Phi Alpha, University of San Francisco, San Francisco, Calif.; Phi Alpha, Bethany College, Bethany, W. Va.; Sigma Chi Epsilon, California State College at Fullerton, Fullerton, Calif.; and Phi Alpha, University of the Pacific, Stockton, Calif.

Numerous Chapters were awarded trophies. Michigan Iota-Beta (Michigan) received the trophy for the Most Improved Scholarship and Texas Alpha (Texas Tech) was honored for attaining the Most Outstanding



Scholarship for a two-year period, 1966-68. Kentucky Beta (Western Kentucky) received the Efficiency Trophy for its promptness in submitting reports to the National Office.

Ohio Epsilon (Cincinnati) was accorded the trophy for the Most Outstanding Scrapbook, Ohio Kappa (Bowling Green) the trophy for the Most Outstanding Alumni Newsletter, and Indiana Gamma (Indiana) the trophy for the Most Outstanding Rush Brochure.

In addition to Past ESA Beck, two stalwarts of the Fraternity, Past ESA Glen T. Nygreen and Board of Trustees Chairman Halford J. Pope, were presented Distinguished Service Awards at the closing banquet Tuesday evening. The main address was delivered by Dr. Emerson S. Shuck, President of Eastern Washington State University and an alumnus of our Ohio Kappa Chapter at Bowling Green State University.

The delegates approved the re-districting of Province Pi, creating a new Province, the 22nd within

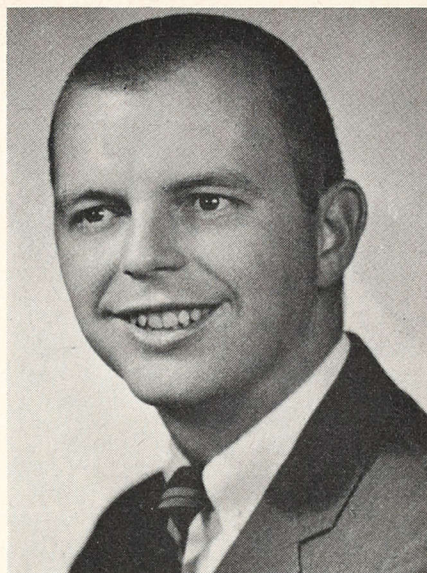
the Realm. Details of the division will be completed at the Province Pi Convention next spring.

As voted on at the 111th Anniversary Convention, the 115th Anniversary Convention will be held in Richmond, Va. The 117th Anniversary Convention will be held in New Orleans, La.

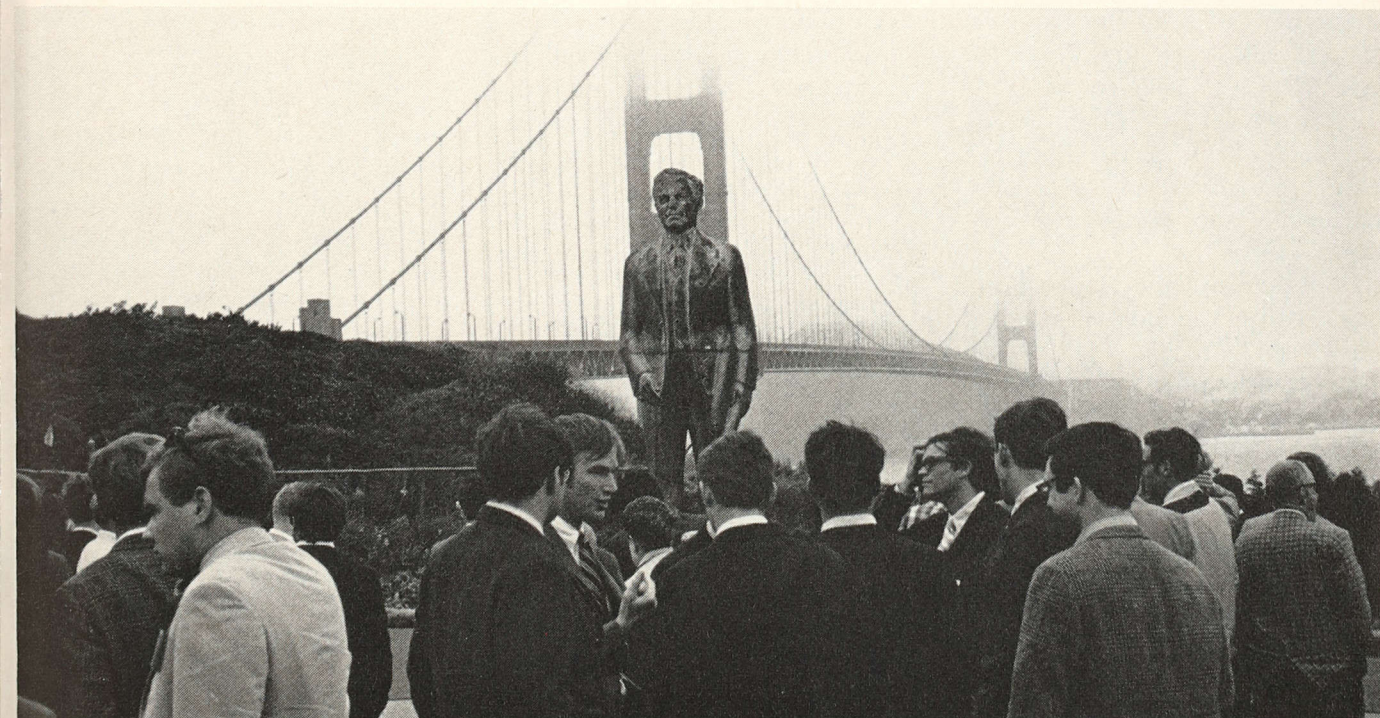
The new Eminent Supreme Recorder, the top administrative position within the Fraternity, has been entrusted to Brother Jack R. Hotaling, '53, New York Delta

The new Assistant Eminent Supreme Recorder is Brother William P. Flournoy, '60, Texas Beta



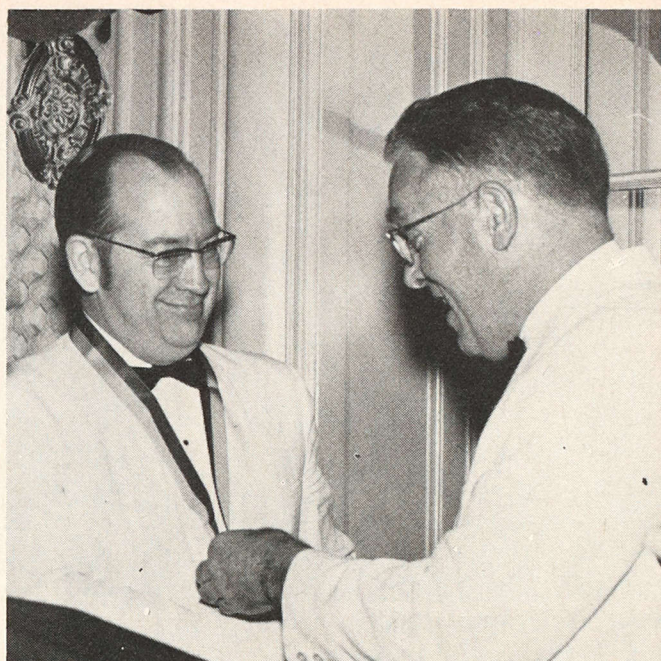

(Texas Christian), a former Chapter Consultant from 1961 to 1964 and at the time of his appointment to the National Office post, Province Sigma Alumni Secretary.

Brother Smith left a successful business career in Lincoln, Neb., to accept the call from the Supreme Council following the death of ESR John O. Moseley in 1956. Long active in  $\Sigma$ AE affairs before his appointment, he has since become recognized as a leader throughout the Greek-letter fraternity system.

He is active in the National Interfraternity Conference, having served on both the finance and executive committees. He is immediate Past President of the College Fraternity Secretaries Association and is currently a member of its executive committee.

Brother Smith is active in the Evanston Rotary Club, the Evanston Kickers Club and the Masonic Order. He and his wife, Harriett, have a daughter, Nancy, and live in Evanston.

Brother Hotaling brings to the ESR's office 11 years of National

Office experience, beginning with duties as a Chapter Consultant, then Assistant to the ESR and, in 1968, Assistant ESR. In the last year he has completely reorganized the Chapter Consultant program and has worked closely with Chapters throughout the Realm.

Also active in the National Interfraternity Conference and the College Fraternity Secretaries Association, Brother Hotaling has prepared several manuals dealing with Chapter operations and the duties of officers within the Chapter.

He is an Evanston Rotarian, devoting much time to the club's work with young people. He is also a member of the Evanston Kickers Club and the Evanston Historical Society.

"The leadership capability of the Supreme Council is unsurpassed, and the National Office staff is unified in purpose and dedication," said the new ESR. "This is why I am excited about the possibilities, opportunities, and challenges that present themselves to us in the days ahead."

Brother Flournoy brings to the National Office a business background that includes experience as a sales representative with a large insurance company and four years of varied key administrative positions for the Fort Worth, Tex., National Bank.

Active in numerous campus organizations and holder of several awards as an undergraduate at Texas Christian, Brother Flournoy held practically every Chapter office at Texas Beta. He has attended and has been a faculty member at the Leadership School and has attended four National Conventions.

Brother Flournoy is married to the former Dale Simmons Blanchard. The couple has two children, Joseph, 3½, and Noelle, six months. They will reside in Evanston after Aug. 15.

Delegates to the 113th Anniversary Convention acted upon 53 proposed amendments to the National Laws. Due to the limited space available, only the major



amendments will be presented. They are:

1. Approval of an amendment giving the individual Chapters the sole prerogative in the election of pledges, providing no Chapter's requirement falls below one half, plus one, of the members of the Chapter who are eligible to vote.

2. Approval of two amendments requiring pledges to complete a course of training of at least four weeks prescribed by the Chapter Collegiate, and to meet the institutional requirements of the university prior to initiation.

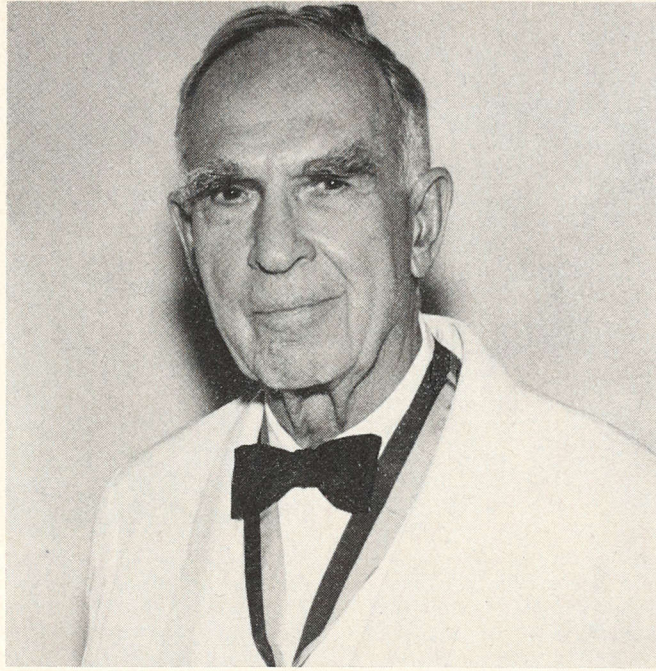
3. Approval of an amendment increasing the National initiation fee from \$65.00 to \$75.00, and keeping The Record Life Subscription fee at \$10.00.

4. Approval of an amendment creating a colonization procedure, whereby at least four members of the Supreme Council may determine and take whatever action necessary to establish a colony, making it clear, however, that establishment of a colony is not a guarantee that a charter will be granted.

5. Approval of an amendment whereby a petition may be filed by either a colony or existing local provided it has been approved by a majority vote of the Province in which the institution is located, the petition is signed by at least 12 persons eligible to membership in the Fraternity, the petition is filed with the Eminent Supreme Recorder and is accompanied by a charter fee of \$500.00.

6. Approval of an amendment that would, by unanimous vote of the Supreme Council, allow a direct mail vote on petitions by individuals and groups entitled to representation in the National Convention. A three-fourths affirmative vote within 45 days is needed for the granting of a charter.

7. Approval of an amendment increasing the permissible total indebtedness of any Chapter from an average of \$10.00 per active mem-



Honorary ESA Norman H. Pritchard

**T**ruly one of the great Brothers in the Realm of Minerva has been accorded the high honor of Honorary Eminent Supreme Archon of Sigma Alpha Epsilon.

Norman H. Pritchard, '04, Indiana Alpha (Franklin), General Counsel of the Fraternity since 1924 and one of the incorporators of The Levere Memorial Foundation, was nominated and elected at the 113th Anniversary Convention in San Francisco.

Brother Pritchard, who celebrated his 85th birthday July 4, is a member of the Chicago law firm of Chapman, Pennington, Montgomery, Holmes & Sloan.

Founder Member No. 29 of The Levere Memorial Foundation Sustaining Fund, Brother Pritchard was appointed General Counsel by Brother Billy Levere in 1924 and has served in that capacity ever since. He is the holder of the Merit Key and the Distinguished Service Award, Chairman of the Advisory Council of the Levere Memorial Foundation since it was created at the Fort Worth Convention in 1940, and has served as Chairman of the Permanent Committee on National Laws for many years.

Brother Pritchard has attended most National Conventions beginning with the Washington Convention in 1902.

In addition to an AB degree from Franklin, Brother Pritchard holds a Juris Doctor degree from the University of Chicago Law School and an Honorary LLD degree from Franklin College in 1945. He has been a member of the Franklin College Board of Trustees for over 30 years.

Brother Pritchard attended the first Officer Training Camp at Fort Sheridan in 1916 and served in World War I as a First Lieutenant in the Three Hundred and Thirty Third Field Artillery.

The new Honorary ESA is married to the former Mary Louise (Maidi) Martens. They have two children, a son, Tom, and a daughter, Mrs. Joseph R. Hauck. The Pritchards make their home in Wilmette, Ill.

ber to an average of \$20.00 per active member.

8. Rejection of a proposed amendment that would have allowed an undergraduate in good standing of a Chapter Collegiate to be eligible for the office of Eminent Supreme Chronicler. However, the Supreme Council supported a resolution that will study ways for undergraduate members to have a greater voice in the affairs of the Fraternity.

9. Approval of an amendment creating a committee of six, including two undergraduates, to work with the Director of Leadership Training to prepare programs and formulate plans for the annual Leadership School.

10. Rejection of a proposed amendment that would have permitted the use of the membership badge, or its design, upon an article of jewelry.

11. Rejection of a proposed amendment that would have allowed only the obituaries of leaders in the Fraternity, or in business or public life, to be printed in *The RECORD*.

12. Approval of an amendment that now sets aside \$6.00 out of each initiation fee received from Chapters Collegiate for a Convention Fund.

13. Rejection of a proposed amendment that would have made the Chapter Consultants members of the National Convention, but approved an amendment that makes the Assistant Eminent Supreme Recorder and the National Treasurer members of the National Convention.

In addition, delegates debated for nearly three hours proposed changes in the ritual of the Fraternity, as recommended upon by a committee headed by Past ESA Emmett B. Moore, '24, Mont. Alpha (Montana State).

Many changes were approved by the Convention, and at press time Brother Hotaling reported copy for the revised ritual was completed by Brother Moore and was on its way to the printer. Copies will be sent to all Chapters as soon as they are available.

# Summer Counseling Program Begun

An imaginative new program instituted this summer by the Sigma Alpha Epsilon Leadership Foundation found four Brothers serving in the Columbia, S.C., area as interns in the Summer Counseling Program.

Selected for the program were William W. Frank, '70, Calif. Delta (UCLA); Stephen J. Ironhill, '69, Calif. Theta (San Diego State); J. Michael Simpson, '70, Ind. Gamma (Indiana); and Dennis D. Weisenburger, '70, N.D. Alpha (North Dakota). Selected as alternate was Stephen A. Horvath, '71, Ohio Mu (Denison).

The Counseling Interns were selected by a committee composed of Eminent Supreme Warden Joseph A. Mancini, Project Administrator and Province Omicron Archon William P. Brickle, and Eminent Supreme Chronicler and Educational Advisor Dr. Neal R. Berte.

Brother Brickle, '60, S.C. Gamma (Wofford), is employed by the Special Services Section of the Columbia Area Office of the South

Carolina Vocational Rehabilitation Department.

Each Intern was assigned to work with a counselor in a special area of rehabilitation. The program was devised to allow college undergraduates to work with adolescents and young adults from 12 to 19 years of age.

The four successful applicants were allowed to select one of three broad areas in which to work. The areas included psychological disability, juvenile and domestic relations (family-environmental problems), and juvenile corrections (youthful offenders who have been referred by the Department of Corrections).

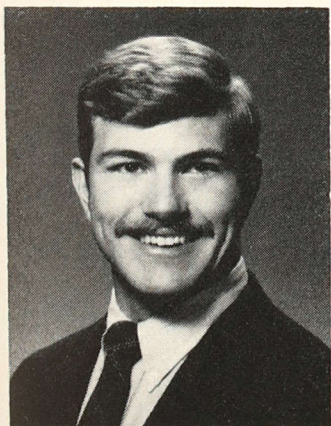
Brother Frank plans a medical career following graduation from UCLA. He has worked in two hospitals as an orderly and in the UCLA program, Uni-Camp, he has worked with underprivileged children. Bill is Chapter Chronicler and a member of the Upper Division Men's Honorary.

Steve Ironhill has already accumulated considerable experience

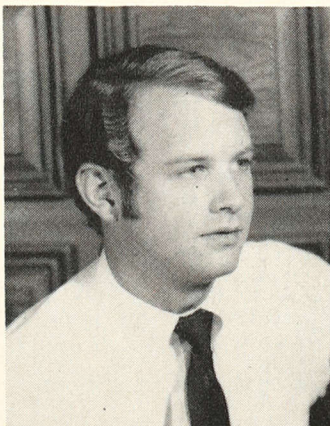
working with the young, teaching mentally deficient children selfhelp skills and in voluntary work with the San Diego Juvenile Hall. He has served his Chapter as EA, EW and ET. His plans include an M.A. and Ph.D., and counseling in or the practice of psychology in juvenile or minority group problems.

Brother Simpson has compiled an outstanding scholastic record, holding a 3.70 average. His job experience has included work with underprivileged teenagers for the YMCA and weekend work in recreational therapy for a mental hospital.

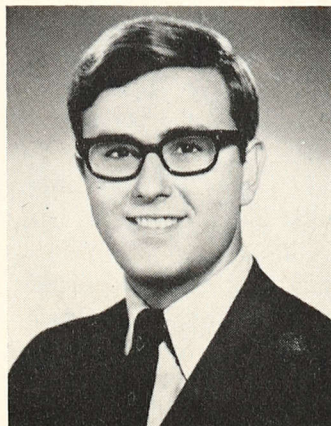

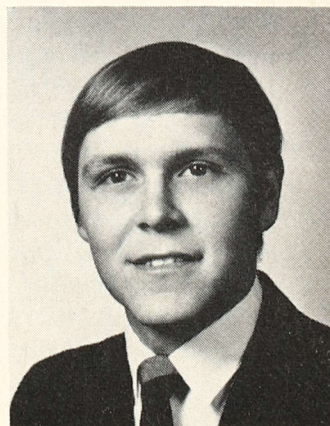

# NEW LEASE ON LIFE



*A two-month training program was needed to teach Dick and Marlys the use of the artificial kidney. The pilot program was conducted by the Chronic Home Dialysis Center of the University of Texas Medical Branch in Galveston. The bloodcleaning operation was later transferred to the Sifers' home in Guthrie, enabling Dick to continue his normal routine of work and community life.*

There's a mighty "big" man living in the town of Guthrie, Oklahoma. His name is Richard L. (Dick) Sifers, '61, Oklahoma Mu (Oklahoma State), and he's not that big in physical stature. Rather, he has the heart of a lion and the almost fierce desire to live a full and active life.

Dick Sifers has a rare kidney disease, and only through a new self-care artificial kidney program has he been given a new lease on life.

Almost sixteen months ago, Brother Dick made Oklahoma medical history when he became the first person in the state to benefit from the artificial kidney program at the University of Texas Medical Branch

in Galveston, Tex. It was in February of last year that Dick was told an irreversible renal failure would be fatal if not checked immediately.

Dick and his pretty wife, Marlys, made the trip to Galveston, were immediately screened, evaluated and accepted into the then month-old program. They were the third couple to be accepted and Dick was the second man to graduate from the experimental center, one of 12 similar projects in the nation.

"I think it's a great program," said Dick, when he returned to his home in Guthrie. "It's a chance to live." And with the kind of active life Dick was accustomed to, this was all he wanted.



Purpose of the center in Galveston is to determine the value of training persons with chronic kidney failures to care for themselves at home. They usually require hospital care.

For two months, Dick and Marlys studied the medical and mechanical aspects of the program, and Dick underwent a blood-purifying, dialysis treatment three times a week, just as he does at home now.

"It's not difficult, when you consider the alternative," says Dick. "The machine works while I sleep, about eight hours. All I watch is my diet."

Dick's diet is the responsibility of Marlys. She keeps him on a low-salt and protein-restricted program. She also has been trained to calculate nutritional values on menus that have clinical approval.

When the Sifers returned from Galveston in May, 1968, they brought with them an artificial kidney machine immediately installed in the couple's bedroom. The machine offers maximum safety but an alarm system warns of malfunction. They are trained to locate a problem and correct it.

In the early stages, Dick had a surgically-inserted "shunt" in his arm to carry blood by plastic tubes to and from the machine. Blood was filtered by osmosis through a series of cellophane membranes. Purified blood returned to the body through venous tubing.

The "shunt" is now in the leg, which has enabled the sports-loving Sifers to return to his regular tour of the local golf course.

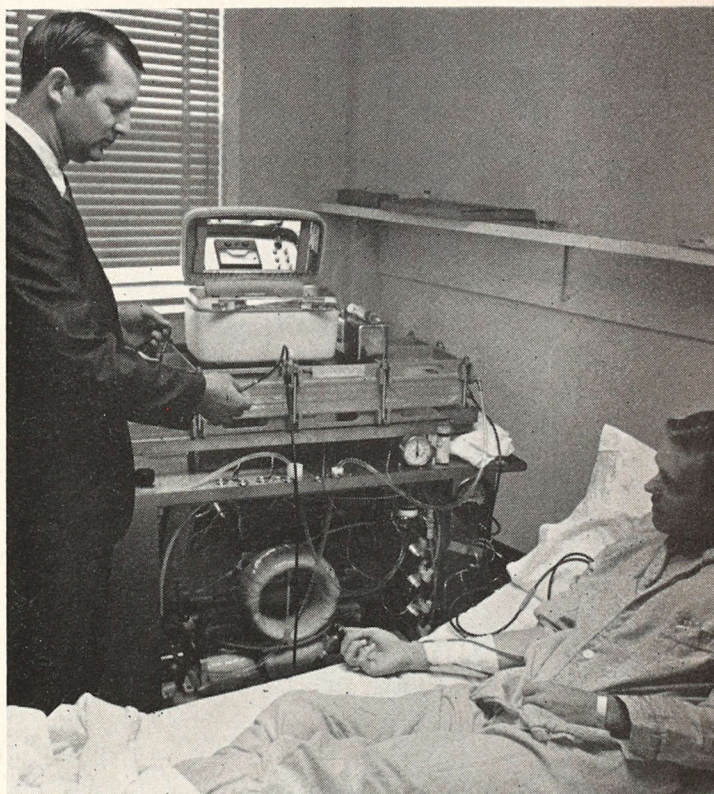
Assistance has come from Dr. Robert Hogue, Dick's family physician, who traveled to Galveston to be briefed on the hemodialysis treatment.

If the artificial kidney did slow down Brother Sifers sports activities, it did little to interfere in his job at Guthrie's First National Bank and his numerous civic responsibilities.

Dick was voted the Guthrie Jaycee's "Outstanding Young Man of 1968" and is a member of the Lions Club and the Guthrie Scottish Rite Consistory. He is a Past Worshipful Master of Guthrie Lodge 35, A.F.A.M., chairman of the Trinity Chapter DeMolay Advisory Board, serves as treasurer of the Red Cross chapter and is a member of the board of directors of the United Community Fund.

The popular Sifers is also president of the Logan County Oklahoma State University Alumni Association, president of the Gamma Alpha chapter of Beta Sigma Phi and a member of the First United Presbyterian Church.

The couple have two children, Kristen and Sherri.

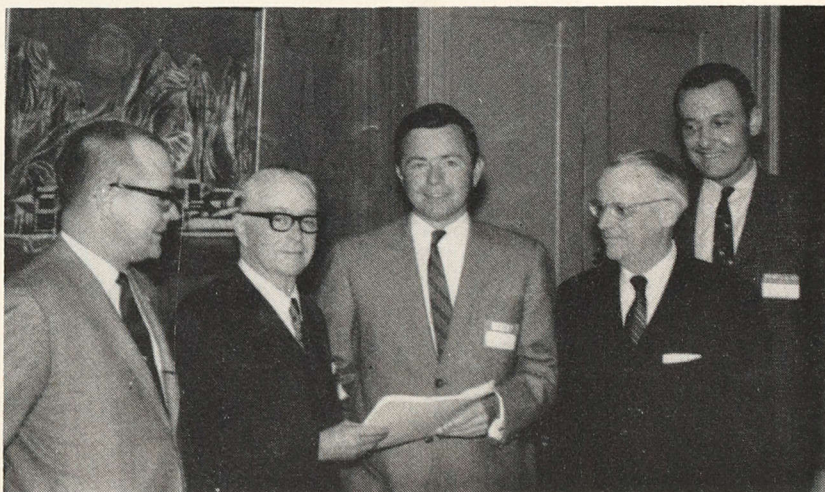

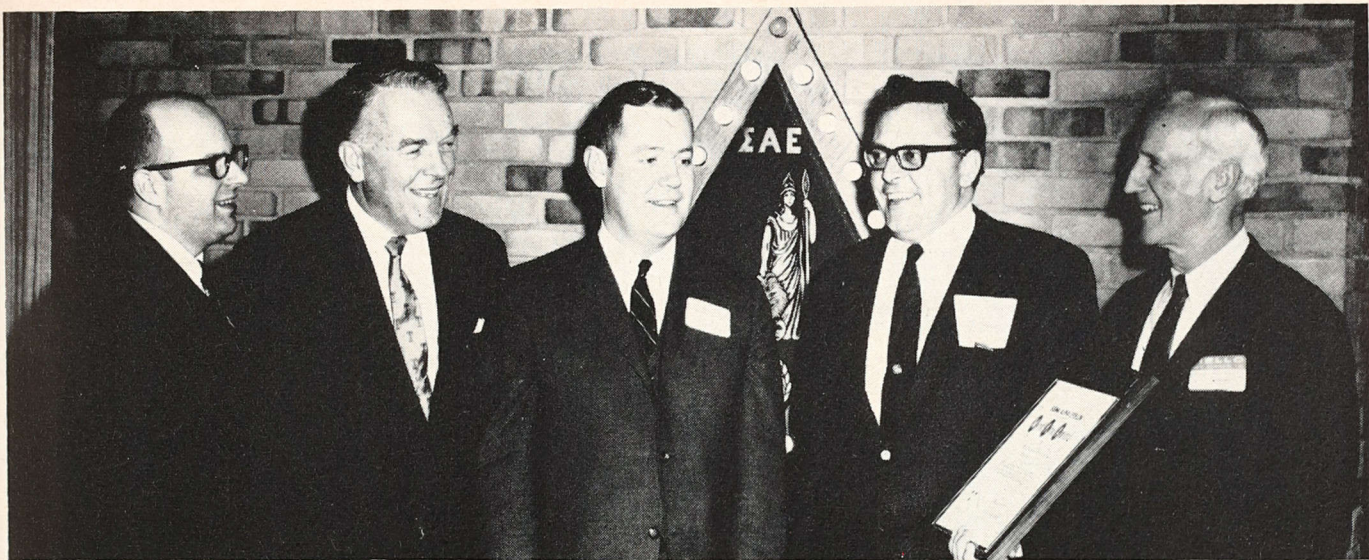

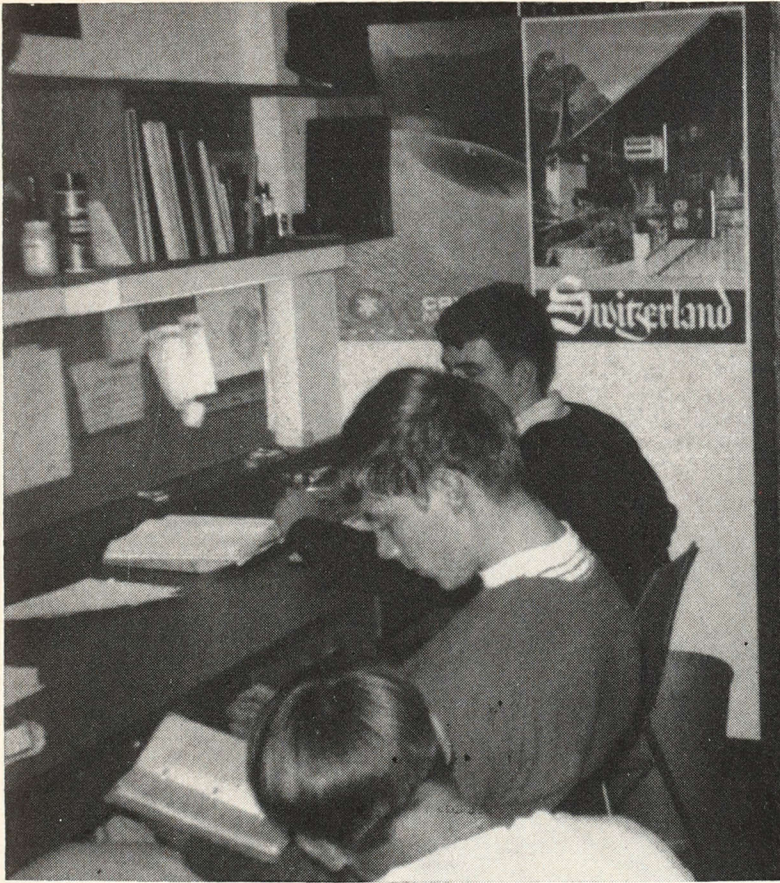
In 1913, a small group of University of Idaho students formed a campus living group called the Zanda Club. The group changed the name to Zeta Chi Alpha in 1916 and began to develop a strong fraternity. The brothers, although only twenty-six in number, were a spirited group and attracted the attention of Washington Beta who urged them to petition ΣAE. At the Buffalo Convention of 1919, Lyle Colburn represented ZXA and was Chapter EA.

After the Convention, Billy Levere officially installed Idaho Alpha Chapter into Minerva's Realm on November 1, 1919. This was the birth of an exciting, innovating and hard working Chapter and fifty years later this zeal still remains.

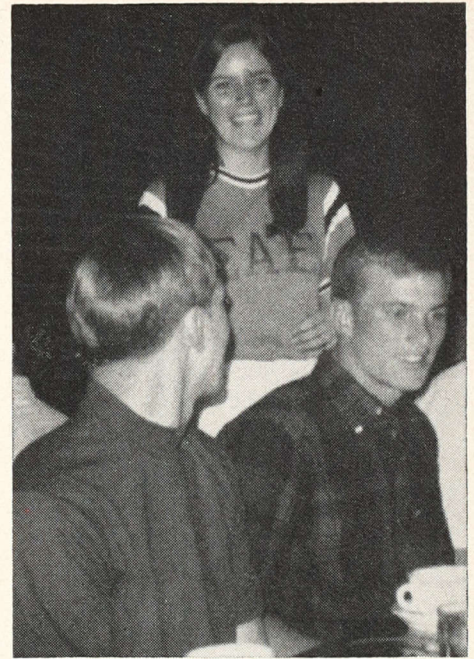
This zeal was demonstrated by Brother Leon Perrine, a member of the 1922 Olympic team and Idaho's only Olympian. Other stars have been Fred Quinn, one of Idaho's three all-American basketball players, and Hamer Budge, present head of the Securities Exchange Commission. In addition, Idaho Alpha claims Col. Reginald Myers, the only winner of the Congressional Medal of Honor ever to graduate from the University.

What these men helped develop was an organization proud of its heritage. The *Gem of the Mountains* claimed Idaho Alpha's motto as "They take the Rest" in 1920, but today it would be modified to "We take the Best."

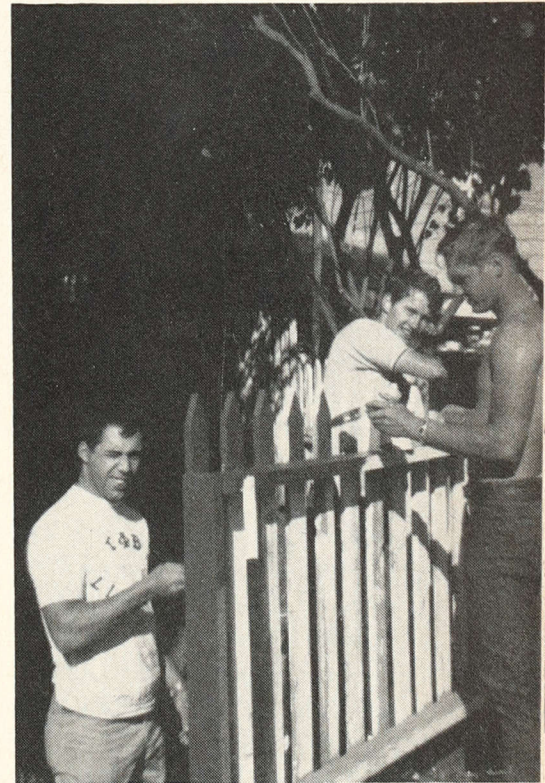

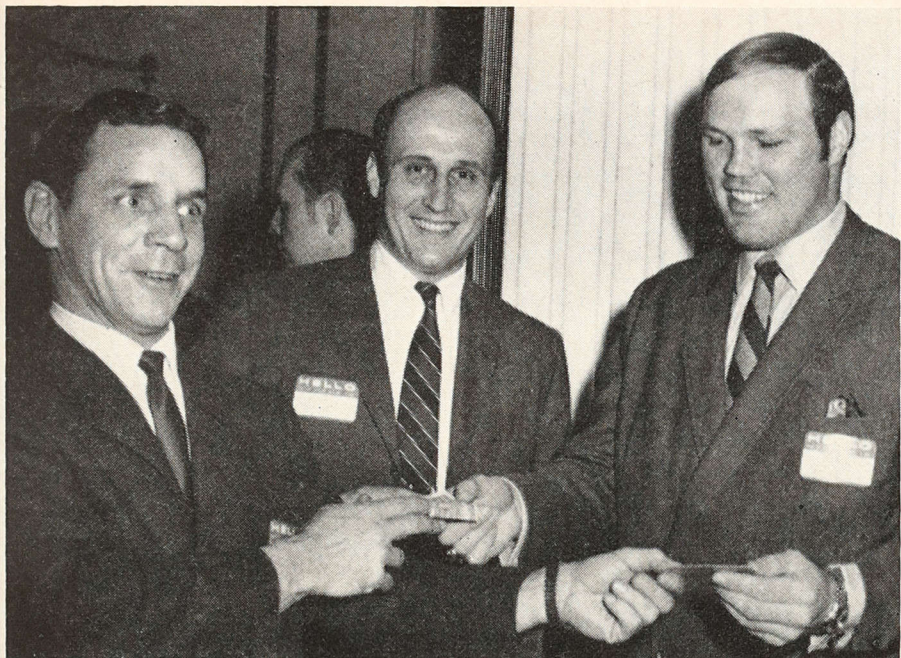
One of the strongest, and the largest, Alumni Associations of Sigma Alpha Epsilon is located in the Motor City, Detroit, Michigan. With a mailing list of 500 Alumni Brothers, Detroit quite possibly qualifies as one of the largest fraternal alumni associations in the country.

Pre-World War II history of the Detroit Alumni Association is very sketchy. The post-war formation took place in the late Fall of 1946 in the inner recesses of Bill Muer's Fish Works. Brother Bob Elder had been the prime mover in getting the gang together, and in recognition of his being the lead horse, he was elected president. Since Brother Bob Clark was the only Brother present who owned a fountain pen and knew how to read and write, he was acclaimed secretary.

Prior to Founder's Day, 1947, the first issue of the "Alumnews" was published. Its birth was hailed by such comments as, "the type's so damned small I can hardly read it." Since this humble beginning, four issues of the "Alumnews" are published annually.

Present at the initial meeting in the bowels of Bill's building were such stlawarts as Ivan Fiscus, Ed Sisk, Herb Paetz, Charlie Hendrick, Buz Bozell, Don Robinson, John Long and others. The reality of "others" has hazed off into that

vale of indistinction which so often accompanies the recollection of happy memories. In 1950, Bill Fiscus was graduated from Michigan State University and joined the Alumni Association. No one dreamed that Brother Bill would still be the thorn in the group's side 20 years later.

The Detroit Alumni Association is unique with its weekly luncheon meetings held at Joe Muer's Oyster House every Wednesday at high noon. From 15 to 30 Brothers attend, with new faces appearing each week. Along with the luncheon meetings, six major events are staged throughout the year.

and the Christmas Luncheon at the Bayview Yacht Club with Ivan Fiscus host.

The Association boasts four Brothers on Province Pi's Council. They are Ralph Recor, Archon; Warne McClelland, Recorder; Dave Rentschler, Alumni Secretary; and Bill Fiscus, Province Advisor. Past Province Archons include Bob Clark, Ed Pogor, Bill Fiscus and Ed Pellowe.

Due to the critical state of the treasury this year, a new concept of dues paying was initiated by the Board of Directors. An urgent call was sent out to all Brothers to become "sustaining members" at \$15 per year instead of the usual \$5. The treasury rose from less than \$100 to over \$1,000 in a period of two months.

Bi-annually, the Detroit Alumni Association publishes the most complete Alumni Directory in the Realm of Minerva. The Directory is financed through the generosity of many advertising Brothers. No Brother appears in the Directory

unless his name is on the Association's address-o-graph mailing list. Chapter classification is located at the back of the Directory. The 1969 Directory will contain the names of all 50-year recipients plus all the past presidents.

At each Founder's Day a \$150 cash award is presented to the most outstanding Chapter in the State of Michigan. All factions of good fraternity living are carefully evaluated, such as financial, rush, community service, reporting and scholarship. This year's winner was Michigan Alpha at Adrian College.

Elaborate plans are being formulated for a new event this year. An all-night stag boat cruise is being planned to Toledo, Ohio, to visit the Brothers of the Toledo Alumni Association.

# Ohio Wesleyan Names Dr. Wenzlau President

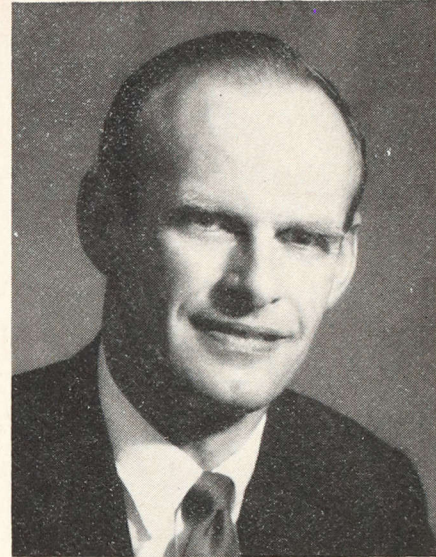

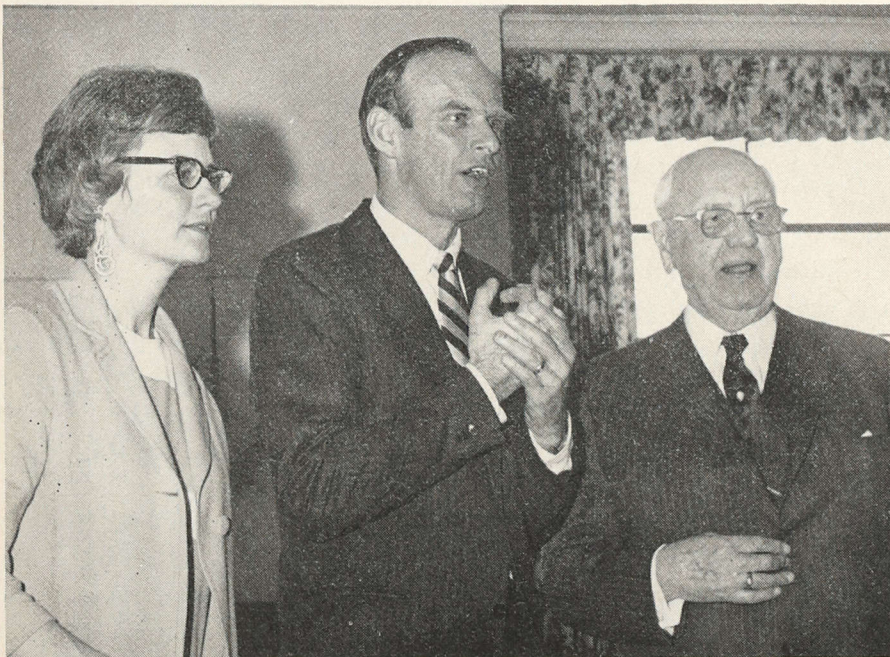
Brother Wenzlau served as Eminent Archon of Ohio Delta his senior year, was Sophomore Class President and a candidate in 1948 for Student Body President.

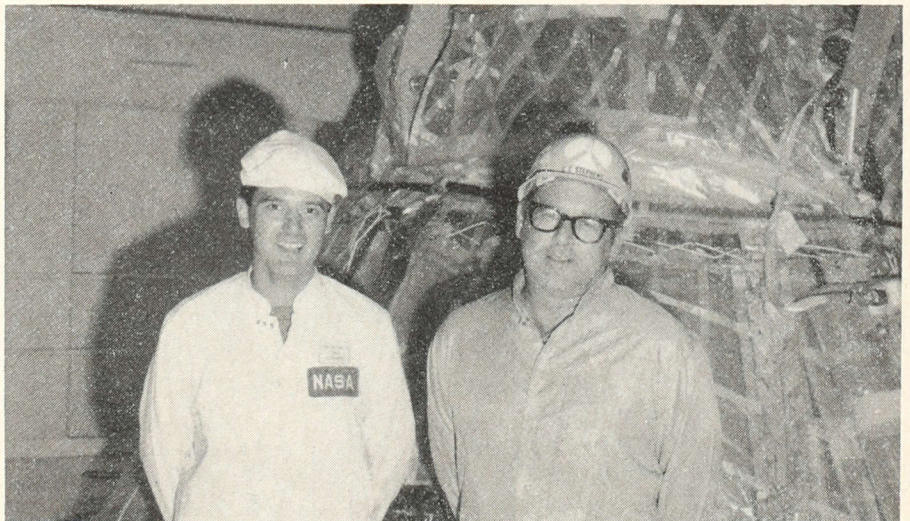

# Ohio Kappa's Dr. Cooke Retires

After 32 years of teaching business and finance at Bowling Green State University, Dr. Gilbert W. Cooke, a Five Brother and the man responsible for the chartering of Ohio Kappa, is retiring this year.

Dr. Cooke came to Bowling Green in 1937 as an assistant professor of business administration.

Born on a farm in Hammond, Minn., Brother Cooke received a B.S.E.d. degree and a MA degree from the University of Minnesota. He taught at the University of Pittsburgh from 1929 to 1933 and the University of North Dakota from 1934 to 1937. He received his Ph.D. degree from the University of Wisconsin in 1936.

The year 1937 saw Dr. Cooke come to Bowling Green, and be initiated and then named advisor to The Five Brothers Fraternity.

It was Dr. Cooke, along with the late Brother Ivan "Doc" Lake, who enabled Five Brothers to receive a charter from Sigma Alpha Epsilon in 1945. He was initiated in 1945 as one of the charter Sig Alphas at BGSU.

In 1953, Dr. Cooke became a Democratic candidate for councilman-at-large. He was elected and later served as president of city council. He was the first University faculty member to be a candidate for public office in Bowling Green. He continued in community service by winning a seat on the Board of Education, which he held from 1955 to 1963.

It was through Dr. Cooke's efforts that the city of Bowling

Green saw the development of an extensive school building program. He has also been a member of the City Planning Commission and the Bowling Green Chamber of Commerce.

In 1960 the city bestowed upon Brother Cooke its highest honor by naming him its Outstanding Citizen. The University awarded him the Samuel S. Casper Distinguished Faculty Award for Superior Teaching in 1965.

Dr. Cooke is the author of four textbooks concerning business techniques, and has written six articles on North Dakota Industrial programs and savings in financial institutions.

But most of all, Dr. Cooke has devoted his time and ability in helping Ohio Kappa grow and progress since 1937. His guidance has been essential to our sound financial condition.

His foresight led to the formation of a housing corporation that now is becoming the most important part of Ohio Kappa's programs for the future.

The Brothers of Ohio Kappa honored Dr. Cooke with a testimonial banquet held Apr. 19 in Bowling Green.

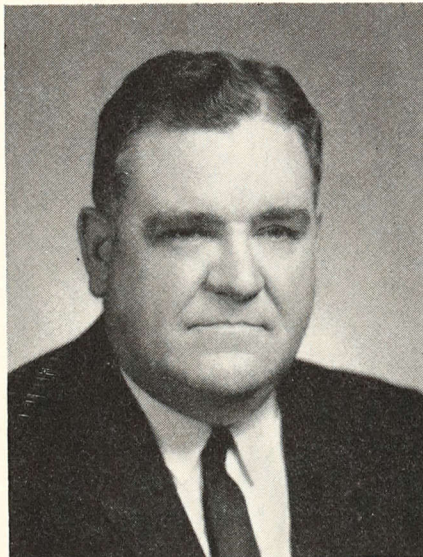

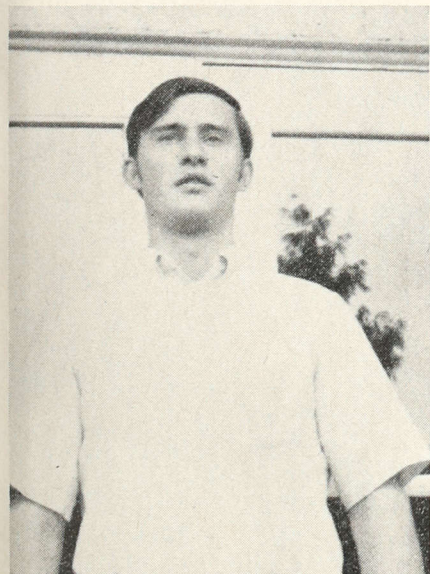

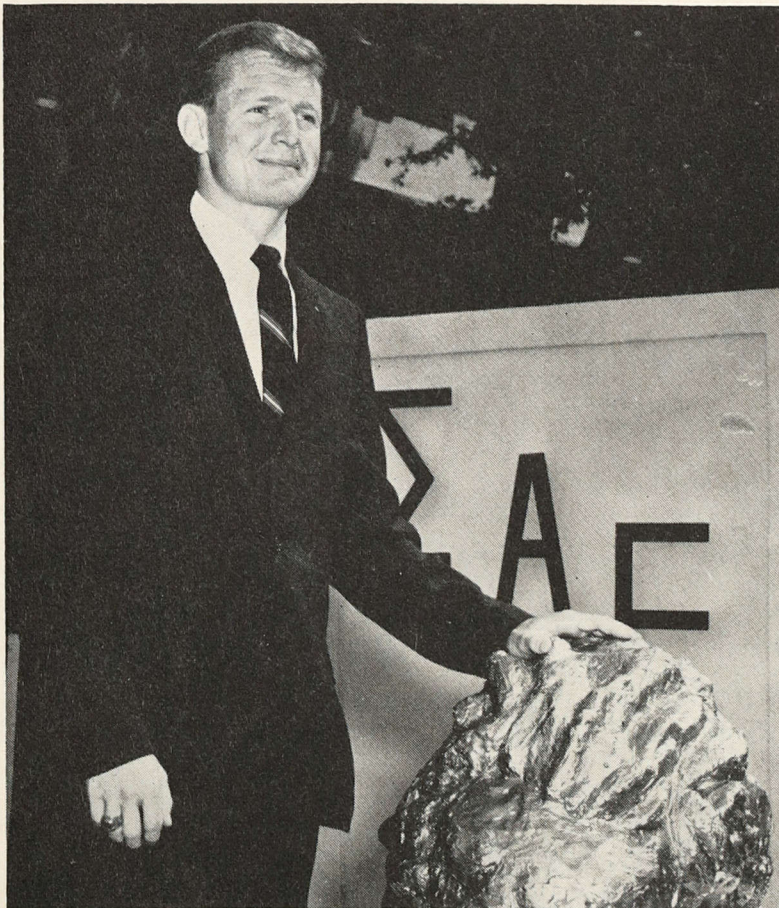

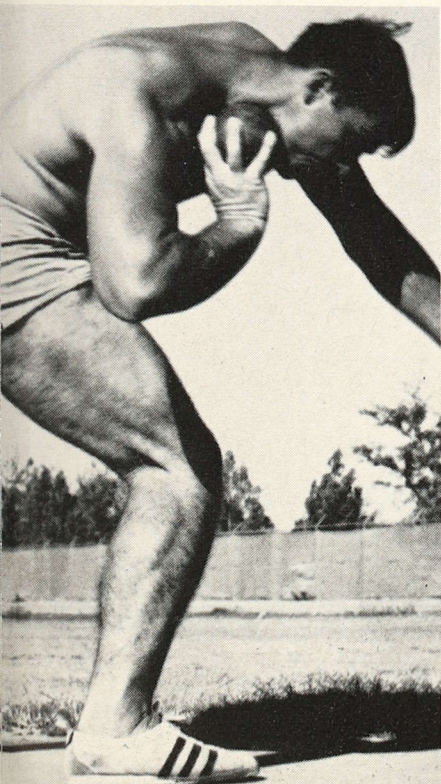

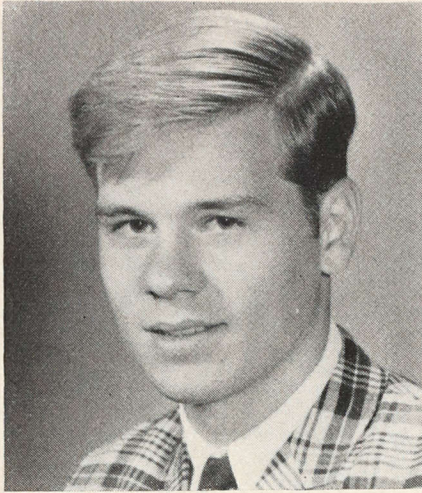

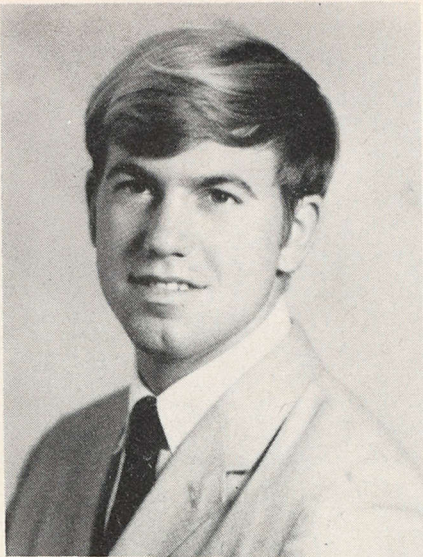
