SAVE A LIFE

Smoke detectors have become a hot item in the \$1 billion-a-year fire equipment industry. At least 25 states have passed legislation requiring the installation of detectors in new or improved living units, and the Department of Housing and Urban Development requires that all homes with FHA and VA mortgages have them as well.

Twenty-five companies now manufacture residential smoke detectors which are in the price range of \$30.00 to \$80.00. There are two types on the market, the most popular being an ionization detector, which uses a radioactive cell to create an interior electric current. Another type is an AC-powered photoelectric model.

Ralph Nader's research group has reported that ionization detectors are a potential health hazard because of their radioactive element, though it is generally agreed that the greatest danger lies in not buying any smoke detection system at all. The National Bureau of Standards estimates that half of the 7,000 people killed each year in residential fires could have been saved had they been warned of fumes and smoke.



CONSULTANTS

1977 NATIONAL CONVENTION

Before a chapter's delegates can be seated at the 1977 National Convention in Philadelphia, a report from the National Office regarding each chapter's reporting and financial status is submitted to the Credentials Committee. (This status is prescribed in Article 29 of the National Laws.) The report will address all delinquencies in reporting and fee payment to our Office, as of December 31, 1976. The Credentials Committee then determines who will and will not be seated at the Convention. By this time, each chapter should have received a letter from the Director of Financial Affairs, which explains each form and fee. The Consultant will follow up on each delinquency as the Convention approaches, to help your chapter clear up any debts and be seated in Philadelphia. Any questions regarding credentials, and the Convention in general, should be directed to me.

IDEAS FOR EA's

Identify with the executive council and chapter specific goals for the term, and seek commitment of brothers to work toward their achievement.

Review the EA's report of your successor and study the facts and opinions regarding the current strengths and weaknesses of the chapter. From this study establish your objectives. Write them out and post.

Develop plans for accomplishing goals, assign brothers to specific tasks, and recognize accomplishment and service of brothers, advisors, etc.

Be sensitive to the needs, concerns and problems of those your serve.

Investigate problem areas by forming a "task force" to study the problem and recommend solutions. Members of the "task force" should be open-minded and represent both the pro's and con's on the issue.

Behavioral problems should be handled on an individual basis; avoid public reprimands. Seek the support of the brothers in dealing with problems.

Speak to each officer and chairman about his responsibilities and check periodically to see that progress is being made in the carrying out of duties. Be positive and supporti on an individual basis.

Utilize your support groups in achieving your goals. (Advisors, faculty, National Officers and staff, province officers, fraternity dean, etc.)

Make sure new brothers and pledges are assigned tasks that will train them for future leadership roles.

Post the agenda and minutes of meetings and disseminate important information through influential members and the executive council.

Maintain a good file system to cover all aspects of chapter operation.

Hold executive council meetings regularly in order to keep everyone informed and provide an effective forum for discussion of issues. Each member of the executive council should set goals for himself and share them with the chapter. An Officer's Retreat can start the term off right!

Establish a "Chapter Development Committee" to plan programs for leadership development, resolution of issues and problems, goal setting and program planning, etc. This committee can study all present programs such as pledging, community involvement, social, retreat, and so on, and structural areas such as by-laws, kitchen, housing, etc. to see if the structure and programs are helping or hindering the achievement of the chapter goals.

Organize an "advisory group" of seniors and past officers to study the needs of upperclassmen and provide programs whic will keep then interested and actively involved.
